Directions to Jester Park Riding Stable

I-80 to Highway 141 West (Exit 127)
Hwy 141 West for 5.5 miles (you will actually be travelling north) to Exit 148 - Hwy 415 (NW Saylorville Drive)
Go right (east) on NW Saylorville Drive for 1 mile
Follow signs to Jester Park
Turn left on NW Beaver Drive and go 0.5 mile to NW 107th Street
Turn right on NW 107th street to NW 114th Ave
Turn right on NW 114th Ave and follow 0.5 mile to the stable (NW 114th St becomes NW 103rd Ct)



IASA Winter Practice Show Rules

Horses

Academy Horses must be school horses regularly used in a lesson program and must not be in training.

Academy horses may be entered in Academy classes, show practice, or open classes, except where specified.

Show horses may show in show practice or open classes

NO BLACKING OR BRAIDING!

Equipment

Unless otherwise stated, academy classes are Saddle Seat and require a flat English type saddle. Any type bridle may be used.

Show Practice horses should use appropriate saddles, but any type bridle. Protective equipment optional.

Riding Attire

Jods and jod boots recommended

Use of helmets encouraged

No riding suits

Judging

Classes will be divided as circumstances warrant, with a maximum of five (5) exhibitors per class.

Horses are not to be judged.

Classes are to be judged on the ability of the rider to control and show the horse to the best advantage. Correct diagonals and leads are important.

Age and Eligibility

Rider's age determined as of December 1, 2006

Once a rider has cantered, return to the walk/trot is prohibited.

Rider may not return to a more novice level once he/she has advanced.

A show rider is one who has participated in a class requiring a riding habit at any show

An academy rider is any rider enrolled in a lesson program who has not shown in a class requiring a riding habit.

Class Specifications

Classification of individual riders is up to the discretion of each instructor.

Show Practice - academy and show riders and academy and show horses

Academy Pleasure - academy riders and horses only

Command - To be judged on rider's ability to follow instructions. May be asked for stops, circles, reverse at any gait, etc.
